Ms Lucilla Sioli is the Director for "Artificial Intelligence and Digital Industry" within Directorate-General CONNECT at the European Commission. She is responsible for the coordination of the European digitisation of industry strategy and for policy development in the area of artificial intelligence (AI). The directorate also supports R&D&I in key digital industrial technologies including microelectronics, photonics, robotics and AI. Lucilla holds a PhD in economics from the University of Southampton (UK) and one from the Catholic University of Milan (Italy) and has been a civil servant with the European Commission since 1997.



Dragoș Adăscăliței is a research officer in the Employment unit at Eurofound. His research interests include digitalisation, labour market institutions, employment and social dialogue. Prior to joining Eurofound in September 2020, he was a lecturer in employment relations at the University of Sheffield, Management School. He holds an MA in Political Science from Central European University and a PhD in Sociology from the University of Mannheim.

Cateelijne Muller is President and co-founder of [ALLAI](#), an independent organisation that promotes Responsible development, deployment and use of AI. She is a member of [EU High Level Expert Group on AI](#), that advised the European Commission on economic, social, legal and ethical strategies for AI. She was [Rapporteur of the EESC opinion on Artificial Intelligence and Society](#) and the EESC opinion on the [EU Whitepaper on AI](#) and headed the EESC Thematic Study Group on AI from 2018 - 2020. She advises the Council of Europe on the [impact of AI on human rights, democracy and the rule of law](#). Cateelijne is a Master of Laws by training and worked as a Dutch qualified lawyer for over 14 years prior to committing her efforts to the topic of Responsible AI.



Isabelle Schömann was elected Confederal Secretary at the ETUC's 14th Congress in Vienna in May 2019. She heads ETUC policy on workers' participation and European Works Councils, industrial policy and company law, competition law, labour law and human rights, single market legislation, digitalisation, standardisation, and corporate social responsibility. Previously, she was a principal adviser to the Regulatory Scrutiny Board of the European Commission providing quality control of all impact assessments and major evaluations by Commission services. From 2005 to 2016, she was a senior researcher with the European Trade Union Institute (ETUI) in Brussels, covering European social dialogue and European and comparative labour law, corporate governance and workers' participation, fundamental social rights, and impacts of the 2008 crisis on workers' rights and of the Commission's Regulatory and Fitness Performance Programme (REFIT) on labour rights. Isabelle was legal advisor to the European Economic and Social Committee Workers' Group on the European Pillar of Social Rights. She has a postgraduate degree in social and labour law from the Sorbonne in Paris and has authored and co-authored a wide range of studies on trade union issues.

A Swedish lawyer with degrees in international, EU and tax law. Having joined the European Commission in 1996, he dealt with trade in genetically modified organisms, fundamental rights issues as well as social dialogue. He was assistant to the Director General for Employment and Social Affairs (2000-2005) before leading units dealing with anti-discrimination law and policy, as well as administrative affairs and social inclusion.

In 2015, he took up the position of Director in DG Employment responsible for the development of dynamic and inclusive labour market, improvement of working conditions through effective labour law as well as safe and healthy working environments. The Directorate is also responsible for the efficient and effective programming and implementation of the European Social Fund (ESF+), the Youth Employment Initiative (YEI) and the European Fund for the Most Deprived (FEAD) in Spain, Malta, Romania and Bulgaria (including also the Recovery and Resilience Facility).



David Reichel

David Reichel is a project manager for social research in the Research & Data Unit at the European Union Agency for Fundamental Rights (FRA). He is responsible for managing FRA's research on artificial intelligence and online content moderation. He has extensive experience in working with data and statistics in an international context. Prior to joining FRA in 2014, he worked for the research department of the International Centre for Migration Policy Development (ICMPD) and as a lecturer at the Institute for Sociology and the Institute for International Development at the University of Vienna. He holds a Doctorate in Sociology, and has published numerous journal articles, working papers and book chapters on issues related to citizenship, migration and integration statistics, and human rights.

Ivana Bartoletti is Technical Director, Privacy at Deloitte, and an internationally recognised thought leader in the field of responsible technology. Author of "[An Artificial Revolution, on Power, Politics and AI](#)", she is a [Visiting Policy Fellow at the University of Oxford](#).

Ivana helps global organisations with their privacy by design programmes, and the privacy and ethical challenges relating to Artificial Intelligence (AI) and big data. As a Policy Visiting Fellow at Oxford University, Ivana is leading research on how to advance the global sharing of information in the context of privacy, security, data protection and human rights.

She is founder of the influential [Women Leading in AI network](#). As a sought-after expert commentator and top conference speaker, Ivana appears frequently in the UK and European broadcast and print media, cutting through complexity to make the key issues clear to the citizen (BBC, Sky, RAI, Guardian, Telegraph, Il Corriere della Sera, El Pais, Agenda Digitale etc.). Ivana was named 'Woman of the Year' (2019) in the Cyber Security Awards in recognition of her growing reputation as an advocate for equality, privacy and ethics at the heart of tech and AI.

Valerio De Stefano

Valerio De Stefano is the BOF-ZAP Professor of Labour Law at the Institute for Labour Law of the University of Leuven. His research focuses on Artificial Intelligence, People Analytics and the workplace and platform-based work in the gig-economy. He holds a PhD in Law of Business and Commerce from Bocconi University, Milan (2011). From 2014 to 2017, he was an officer of the International Labour Organization. He recently edited a special issue on AI at work for the Comparative Labor Law & Policy Journal. He is the principal investigator of several major grants about labour and technology, including from the FWO - Research Foundation Flanders and Horizon2020. In 2020, Valerio was awarded the Service to Society Prize by the KU Leuven for his public engagement based on his research. He has been consultant for the ILO, several EU institutions, and national governments. He is the co-editor of the Dispatches section of the Comparative Labor Law & Policy Journal and a member of the OECD Network of Experts on AI (ONE AI).



Birte Dedden

Birte Dedden is Director of the ICTS (information, communication and technology services) sector at UNI Europa, the European services worker union. UNI Europa represents 7 million service workers in 272 national trade unions and 50 countries. In her current role, Birte is leading UNI Europa's work on AI, focusing on the impact of new technologies on workers. She is also responsible for the ICTS policies and activities regarding digital skills, social dialogue, remote work and European Works Councils. Before joining UNI Europa, Birte has worked as Parliamentary Assistant in the European Parliament working especially on the IMCO and LIBE committees.
