**Open Online Session** A methodology for Gender mainstreaming in the EU budget

Concept note

**Background on Gender Mainstreaming:** 

Gender equality is one of the European Union's fundamental values, as set out in Articles 2 and 3 of

the Treaty on European Union. It refers to the principle that the rights, responsibilities and

opportunities of women and men should be the same.

Gender mainstreaming means actively promoting equality between women and men at all stages and

in all areas of policy-making and implementation. The Treaty on the Functioning of the European

Union provides the basis for gender mainstreaming by obliging the EU to promote equality between

men and women in all of its activities.

**Background on the session:** 

During 2021-2027 MFF negotiations, equality between man and women was agreed as a Horizontal

Principle of the Budget. The Commission has committed in the IIA of 16 December 2020 to develop a

methodology to measure gender relevant expenditure at programme level in the MFF 2021-2027.

The Commission will implement that methodology as soon as it is available and no later than 1st

January 2023.

In the recent European Courts of Auditors Special Report on Gender mainstreaming in the EU budget:

time to turn words into action, which covers the period from 2014 to February 2021, the Court

concluded that the Commission's strategy for gender equality has not yet been realised gender

mainstreaming in the EU budget. The Commission's institutional framework, although reinforced, did

not yet fully support gender mainstreaming. The Court recommended that the Commission

systematically collect, analyse and report on existing sex-disaggregated data for the EU funding

programmes; use gender-related objectives and indicators to monitor progress; develop a system for

tracking funds allocated and used to support gender equality and report annually on the results

achieved in terms of gender equality.

This is specifically timely in view of the large sum of money that the Commission is preparing to

disburse under the new 2021-2027 MFF) and the Next Generation EU instrument.
