"AI's technological diversification to counter market concentration"

"The continuing and ever-increasing corporate concentration and commercialism of the online economy is unsustainable and untenable."¹ The market dominance and market concentration of a small number of Big Tech companies which are developing AI technologies and investing in AI ventures, is increasingly becoming a matter of concern. Increased diversification would ensure a more transparent and democratic environment in the field of AI. Market concentration, monopoly positions and excessive share in the market result in unfair competition, which inevitably increases social and economic inequalities and undermines the public interest². "Large firms are much better placed to take advantage of the opportunities afforded by AI to derive further competitive advantage over their SME counterparts. This could lead to further overconcentration in the market of large firms and multinationals ... The diversification of suppliers and consideration of reshoring some aspects of production to Europe, facilitated by AI and other emerging technologies, could help boost European SMEs."³ At the same time, public investments on AI should focus towards an increased AI diversity in research and innovation.
