The Digital Markets Act is a true step towards an open, fair Digital Union and sets the rules of the game for big platforms providing services to citizens and businesses. What mattered most for me and my group, the Socialists and Democrats, was to put citizens at the core of how digital markets work. It is simply not OK to exploit citizens' personal preferences, behaviours and attitudes to make profits. We are all human beings and not fuel for Big Tech. This is why we pushed for a ban on targeted ads for minors and a better enforcement of personal data protection rules. The dominant market power of gatekeepers forces users to accept their terms and conditions, no matter their content. Citizens have no real chance of using the services of more trustworthy, smaller competitors. Interoperability for messengers and social media services will change this. It will enable users for instance to communicate with contacts on WhatsApp using Signal or to share Facebook content on TikTok. If everything goes according to plan, we will enter negotiations with the Council of the European Union in January 2022. I hope the member states will, under the French Presidency, support this ambitious position for fair and open markets, enhanced consumer welfare and protection of citizens' data.

# VOTE ON THURSDAY 16 DECEMBER Fundamental rights and rule of law in Slovenia, in particular the delayed nomination of EPPO prosecutors

Cyrus Engerer, S&D negotiator on the resolution

We are called to lead by example and uphold the European Union's values of the rule of law, democracy and fundamental rights. Next week, as MEPs from all across the House, we must declare our position on the situation of the government that currently holds the Presidency of the Council of the European Union. Last October, a European Parliament delegation visited Slovenia to hear first-hand about the climate of hostility and distrust that exists, both among the wider public and by public bodies. This can also be seen in the way government dragged its feet and delayed the Slovenian nominations to the European Public Prosecutors Office, which also means interference in the judiciary is now of real concern. The same interference has been extended to the media and freedom of expression, where smear campaigns, slander and funding threats risk doing irreversible damage to the independence of the press and other public bodies. We must uphold and protect our values.

#### DEBATE ON MONDAY 13 DECEMBER AND FINAL VOTE TUESDAY 14 DECEMBER Combating gender-based violence: cyber violence Robert Biedroń, S&D MEP and negotiator of this file in the women's rights committee

The online world is not a safe space for women. Full of traps and 'opportunities' for perpetrators, predominately because of the prevailing impunity, as well as a slow and inadequate criminal justice response. It is estimated that one in ten women in the EU have been victims of sexual harassment via digital tools since the age of 15. Still, this growing and cross-border phenomenon is not properly addressed. There is currently no common definition or effective policy approach to combating gender-based cyber violence at an EU level. That is why in Strasbourg we will call on the Commission to present without further delay a strong directive covering all forms of gender-based violence, including online. We need minimum rules and sanctions to prevent and combat various forms of gender-based cyber violence, as well as ensure that victims have effective access to justice and specialised support services in all member states.
