Christel Schaldemose, S&D rapporteur on the Digital Services Act

The European Parliament starts the year with one of the most important issues of our time: how online services are regulated in Europe. It is stunning, but the current rules date back from the year 2000. This was more than 20 years ago! Meanwhile, the world and the digital sector in particular have changed beyond recognition. This made it imperative for our Group of the Socialists and Democrats to make sure the legislation proposed by the European Commission is of benefit not only to providers of digital services, but also to consumers. Selfregulation of business does not work. It will never work for as long as these digital multinationals care more about their profits than the people. They should not be the ones making the rules. It is our duty to make sure that what is illegal offline is illegal online, too. It is an honour for the S&D Group and to me personally to be in charge of drafting the report of the European Parliament on the Digital Services Act. In the process of drafting the report, I took precious testimonies from all stakeholders involved, including whistle blowers. For the Socialists and Democrats it is clear - we have to put an end to the negative impact of big tech companies' products on users. I am happy my report was adopted with a large majority in the committee on the internal market and consumer protection of the EP. It is now time to vote on the report in the plenary. We fought really hard for the interests of European consumers and I am optimistic my report will be adopted by all MEPs and we will go to negotiations with the Member States under the French Presidency of the Council with a strong position.
