Rising energy prices and market manipulation on the gas market

Finally, the committee on industry, research and energy has adopted the question to the Commission, initiated by us, the Socialists and Democrats, on what are the reasons behind the drastic peak in energy prices; on the ways to lift the burden of unbearable electricity bills off the shoulders of our households and businesses and finally on what is the strategy so that this does not repeat itself next autumn and winter. I expect a very frank debate with the European Commission, especially in the context of the war in Ukraine and the energy supplies we get from Russia. The Russian invasion in Ukraine only made our energy vulnerability visible once more, but even before the war, it was painfully clear. How reliable is Russia under these circumstances? Will the European Commission finally make it a reality something the S&D has long been asking for - the mandatory minimum filling obligations for energy storage throughout the entire EU and not leave the matter to member states themselves? And what about now? The EU's gas storage was only 75% full at the beginning of the cold season, it has now lowered to 28% and is predicted to descend to 18% by April. I am particularly worried we will find ourselves at the end of this winter with depleted gas reserves. Not just me and the S&D Goup, but the entire EU expects answers to this timely question we are asking the European Commission. I hope we will get a reply from the European Commission next week in plenary.

The 170 million workers in the European Union have a right to health and safety at work. The revision of the EU's occupational safety and health strategy for the years 2021-2027 brings a unique opportunity to set out the key priorities and actions necessary for the post-pandemic world, with old jobs disappearing and new jobs emerging in the context of green, technological and demographic changes. Our goal is to reach zero work-related deaths. We continue our work on protecting workers from hazardous substances such as carcinogens, mutagens and reprotoxics, and removing all asbestos. Mental health needs to be on the top of the EU agenda. This is why we call for a Directive on psychosocial risks and well-being at work aimed at the efficient prevention of psychosocial risks in the workplace, such as anxiety, depression, burnout and stress, and a Directive on the Right to Disconnect and a legislative framework with a view to establishing minimum requirements for telework.

In recent weeks, we have witnessed the stepping up of disinformation campaigns by Putin's propaganda machine. Europe is not yet fully prepared to counter foreign disinformation and fight in a disinformation war. The S&D Group insists on the need to better regulate social platforms. We also call for better regulating of political parties financing, including a ban on foreign donations for political activities in the whole of the EU. We do not shy away from naming and shaming and exposing the close links between Russia's disinformation campaigns and the Austrian FPÖ, the French Rassemblement National and the Italian Lega. Our group welcomes yesterday's decision by the Conference of Presidents to continue with the Special Committee on Foreign Interference in all Democratic Processes in the European Union, including Disinformation (INGE), and the important work started with this report on disinformation.

The succession of tax scandals opened the eyes of many to the loopholes created by the current patchwork of national tax systems in the EU, which are abused for fraud and aggressive tax planning. This report calls for a harmonised withholding tax framework that ensures that all dividend, interest and royalties payments flowing out of the EU are taxed at an effective tax rate, also curbing harmful tax competition. The S&D Group calls on the Commission to put an end to profit shifting to tax havens by introducing an EU-wide system for withholding tax.
