**European Council conclusions and the latest developments of the war against Ukraine, and the EU sanctions against Russia and their implementation**

*Iratxe García Pérez, S&D Group president*

Our group has taken a strong and united stance on Putin's brutal war against Ukraine. We definitely need to continue supporting Ukrainians in their heroic defence efforts, and stick to the sanctions against Russia to ensure that the economic consequences will lead Putin to stop his criminal war. We are following the news development in all diplomatic efforts, but we must remain very cautious. Any seemingly positive sign could be another bluff by Russia to buy time. The war has also had dramatic economic and social consequences within Europe, which we must tackle urgently. We welcome progress at the last summit on energy efficiency to make Europe more independent from energy supplies from Russia. The joint purchase of gas is definitely an initiative moving in the right direction. Energy cooperation with the US is essential to isolate Putin and to reduce Europe's dependency on Russian energy. The question of refugees is extremely important and we must make sure that there are enough funds to provide them with the necessary support and access to education, health or housing."

**EU protection of children and young people fleeing the war against Ukraine**

According to the UN, one child becomes a refugee in Ukraine almost every second. Both in the EU and in Ukraine, many of Ukraine's 7.5 million children are in desperate need of security, protection, humanitarian aid and psychosocial care, and the number of children in need is growing by the day. We have already called for the Council and Commission to draw up an EU-Ukraine Child Protection Package to protect and strengthen children's rights. Next week in Plenary, the Socialists and Democrats will use the key debate to make the EU act to meet children's specific needs, including child protection, child-friendly spaces, education and psychosocial support. ### Ongoing hearings under Article 7(1) TEU regarding Poland and Hungary

### The EU's security and Strategic Compass

Putin's war against Ukraine, at the doorstep of the European Union, is a direct challenge to the rules-based system of international relations. In order to give an adequate response to this dangerous shift in European security, the EU must play a more assertive role and become a better and more credible security provider in our continent and beyond. While diplomacy, development cooperation and trade will inevitably remain important foreign policy instruments to promote human security and sustainable prosperity, we must invest much more into the EU's ability to be a capable and an autonomous global actor in the field of security and defence. This will help us defend the rules-based multilateral order. We welcome the adoption of the Strategic Compass, under the leadership of High Representative Josep Borrell, by all member states. This is a big step towards a more robust common security and defence policy through concrete actions like collaborative development and procurement of equipment, more coordinated defence spending, robust tools against hybrid attacks, as well as a Rapid Deployment Capacity, a force of up to 5,000 troops that could be promptly mobilised in case of a crisis. As European Parliament members, we want to play our full oversight role over the implementation of the Compass, notably on the budgetary aspects, to make sure the Council delivers on our joint level of ambition.

### Cooperation and similarities between the Putin regime and extreme-right and separatist movements in Europe

*Andreas Schieder, S&D negotiator in the special INGE committee on foreign interference*

Over many years, close contacts between far-right parties in Europe and Putin's Regime have been cultivated. The Austrian FPÖ, the French Rassemblement National, and the Italian Lega have all signed cooperation agreements with Russian President Vladimir Putin's United Russia party. Media regularly reports that these parties are willing to accept political party funding from Russia. Through our work in the INGE committee on foreign interference, we managed to expose that Russia deliberately seeks out far-right extremist parties and movements to recruit allies within the European Institutions to help them to strengthen their position, to lobby for sanctions relief, mitigate the consequences of international isolation, legitimate their Proxy-Governments, and destabilise Europe. In return, the far-right in Europe can count on very generous support from Russia for their election campaigns. This must stop. This is why we need a ban on foreign donations for political activities in the EU. This is necessary to reduce dark money inflows, increase transparency, and prevent foreign actors interfering in elections and referendum campaigns in Europe.
