The price of electricity will not go down until the EU puts an end to the manipulations with gas on our own internal market. Just changing the architecture of the European electricity market will not bring a tangible and lasting solution to citizens and business - they will keep on paying skyrocketing bills unless we take measures like limiting the profits the resellers of energy commodities can make or suspend transactions on the spot market where we see excessive price fluctuations. In addition, we need concrete social measures, like extending the temporary unemployment scheme (SURE) for people who lose their jobs. We need a recast of the Gas Market Directive in order to make it possible to switch easily from one electricity provider to another and ban the disconnection of consumers from the electricity grids in winter. Our Group wants to see the EU Minimum Wage Directive implemented immediately as the reality has proved how much we need it.

Existence of a clear risk of a serious breach by Hungary of the values on which the Union is founded

By failing to act, the EU is the silent partner that is complicit in Hungary's demise as a democracy. Prime Minister Orbán's racist rant about not wanting to become "peoples of mixed race" was the latest unacceptable attack on EU values and totally undermines the EU's shared commitment to fight discrimination. It is time to wake up and stop Viktor Orbán from doing any more damage. Next week, the European Parliament will vote on a report that sets out a few home truths for the other EU institutions. The Council needs to recognise Orbán's breach of EU values and issue the government in Hungary with concrete recommendations to stop the woeful situation of the rule of law from deteriorating further. The Commission must hold back on approving the Hungarian Recovery Plan due to the real risk that these funds will be misused based on the government's past record of corruption.

Surveillance and predator spyware system in Greece - Council and Commission Statement

Hannes Heide - S&D spokesperson in Parliament's inquiry committee investigating the use of Pegasus and other spyware (PEGA)

As requested by our group, on Monday evening, the Parliament will hold a plenary debate on the latest Greek surveillance scandal. For the record: the Greek government admitted it had been spying on journalists and the leader of PASOK, our MEP Nikos Androulakis, while there was also an attempt to hack his phone with Predator spyware, which was detected by the EP services. Illegal tapping of the phone of a leader of the opposition and MEP is a clear breach of the rule of law and principles of democracy enshrined in our Treaty. We urge the Greek prime minister to give a clear explanation on his knowledge of this scandal. If Mr Androulakis, a candidate for prime minister, is a threat for national security, Greek citizens should know why.

The debate in Strasbourg will be an opportunity to put pressure on the Commission and member states, and to hear what they intend to do. We have seen many cases where innocent people such as journalists and lawyers have been targeted by spyware in other countries, mainly Hungary and Poland, and this is a huge problem for democracy and the rule of law.
