The EU and member states have finally recognised that we need a common and coordinated response to the refugee crisis. It is unfair and unbalanced to let the countries who receive the majority of migrants and asylum seekers deal with this task alone. Now, institutions and member states see the need to engage with non-EU parties, especially, but not only Turkey, in order to tackle it effectively. This is the right approach but we must make clear that defence of human rights and freedom of the press are non-negotiable principles for us. We believe that this new approach of cooperation with non-EU actors should be enlarged to include Libya, Lebanon and major African countries, all of whom have a role to play in the stabilisation of the region and in controlling the flow of migrants and refugees. Now is the time to set up a real and structured dialogue and to demonstrate that the EU and Africa share a common desire to cooperate on migration. The EU cannot limit itself to building walls around its borders or risk messing up objectives aimed at stabilising countries through development cooperation. The creation of a trust fund to help promote stability and foster growth can be a powerful tool to help African countries develop.

**On Terrorism**

It's not just France that is targeted by terrorism but all that we stand for in Europe. These terrorists want to destroy our fundamental values and freedoms. We will not let them; we will never give in to terrorism. Terrorism knows no borders. It has hit this year in Denmark, Tunisia, Egypt, Turkey, Lebanon and now again in Paris. We cannot isolate ourselves behind our own borders. We must stand united and find a common response. More than ever we need a united and cohesive Europe. We have expressed our solidarity with France and supported the Defence Ministers' decision for Article 42.7 to provide aid and assistance to France. Now EU member states must define their means to do so. We strongly support the Commission's proposals to strengthen control of firearms across the EU, including a total ban of certain semi-automatic weapons for individuals, tighter rules to stop online sales and common EU rules on marking and authorizing firearms. These are effective measures members states should implement right away.

The fight against radicalisation and terrorist recruitment is one of the fundamental challenges that the European Union is facing and will continue to face in the coming years. It will determine whether we will be able to win the political and ideological fight against terrorism. We need all EUMS to embrace a comprehensive European strategy, coherently mobilizing all external action tools (CFSP and CSDP) and internal policy and legislative action. Upholding fundamental human rights alongside security is crucial - otherwise we would be playing into the hands of terrorists who aim to instil fear and disrupt our democracies. Every year more than 4.000 workers die due to accidents at work and the number of fatal work-related diseases amounts to more than 150.000 on an annual basis. Even though considerable progress has been made in the area of occupational health and safety throughout the years, workers are still exposed to asbestos and carcinogens as well as many other dangerous substances every day. Many other issues, such as musculoskeletal disorders, the adverse effects on occupational health and safety of precarious employment as well as psychosocial risks also highlight the need for a more ambitious strategy. The Commission must accept its responsibility to promote a safe and healthy working environment. Therefore, we are calling for concrete legislative as well as non-legislative proposals to create a more level playing field and further raise the level of occupational health and safety for all workers across Europe.

### **Developing a sustainable European Industry of base metals**

Base metals (steel, copper, aluminium, zinc...) production in the EU has been undergoing a severe crisis which regularly erupts more acutely here and there in Europe (France, Italy, Belgium, and lastly, the UK): Europe is now facing a simple question: does it want to remain self-sufficient for the production of base metals, which are key for many downstream industries, or not? But our message as Social-Democrats is twofold: yes, we want to keep our industrial production and the highly qualified jobs implied, and we can do that while keeping our ambitious environmental goals.

What our producers need is a level playing field in order to compete fairly with extra-European actors: that is why in addition to reinforced trade defence instruments against dumped imports, the EU needs a border carbon adjustment mechanism. However, to remain competitive, our industries also need to invest again in newer and cleaner facilities as well as in R&D&I (for example through the earmarking of the CO2 allocations they

receive for free), to have access to and predictability reasonably priced electricity (through long-term contracts), and to benefit from a valorisation of scraps (an important raw material for electric steel) in the frame of our circular economy strategy, amongst other ideas contained in the own-initiative report.
